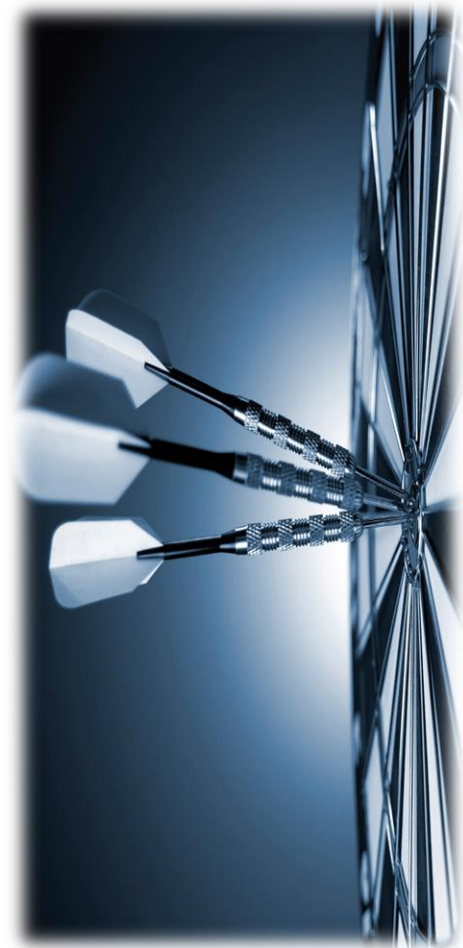

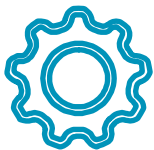


Main objectives of the Association

Popularization of the idea of Safe windows and doors with high-quality hardware. Increase the awareness of the customers about the functionality and capabilities of modern windows.



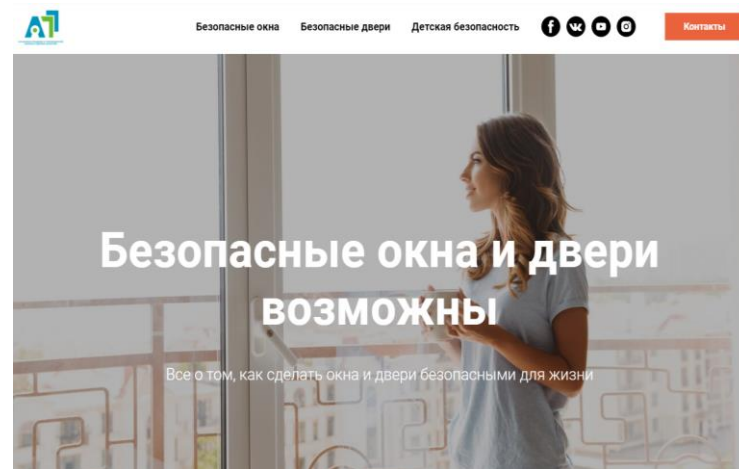
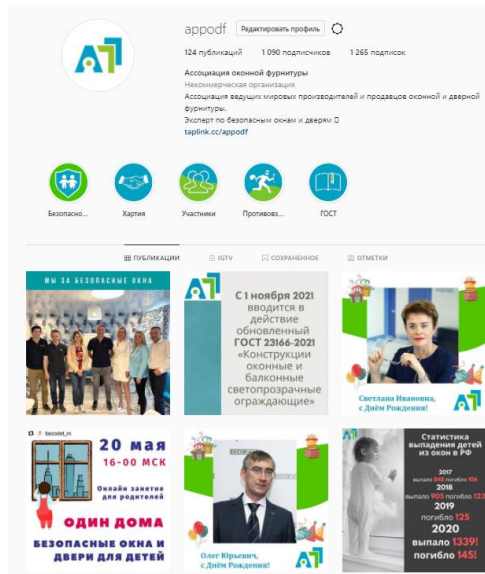

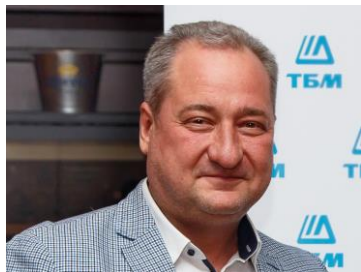

Procedure of joining the Association



To join the Association, the applicant must submit an “Application for membership in the Association”

The application must be accompanied by:

- ❖ Copies of certificates certified by the head of the organization: on state registration, on registration with the tax authority;
- ❖ Certified by the head of the organization copies of the Decision of the competent authority on the appointment of the current head of the legal entity, The charter of the organization;
- ❖ Information about the amount of the organization's annual revenue;
- ❖ If a legal entity exports or imports window or door hardware to the Russian Federation, then together with the application the auditors must be provided with documents for the previous calendar month confirming the correctness of customs clearance.



A new member who has joined the Association is obliged to pay the membership fee for the current year within 30 calendar days from the date of receipt of the notification of admission to the Association in accordance with the "Regulations on Membership Fees" of the Association.
